♦COVID-19 Free PCR Testing Extended to February 10

[Eligible] Asymptomatic people who live, work or go to school in Mie Pref and who are Register and apply through the website; http://www.mwt-mice.com/events/miepcrtest

♦ "Mie Prefecture Guidelines" for COVID-19 Sixth Wave of Infections in Japan **Basics of Infection Preventions**

- Use face masks with reliable quality. If possible, use TNT mesh face masks(Fushokufu-不織布)
- "Keep a distance of 2 meters from other people", "When talking, avoid talking face to face as much as possible"
- "Having meals with lots of people for long periods" in particular increases the risk of infections, so be careful with transmission by droplets etc.
- Even during the meal, wear a facemask when talking (Mask Kaishoku-マスク会食) and avoid talking (Mokushoku-黙食)
- When eating and drinking, "drink alcohol moderately and avoid drinking too much or bar-hopping", "do not share cutlery and glasses", "avoid sitting close or face to face with other people".

About traveling

If you're thinking about leaving the prefecture, try to get around during low-traffic times, take preventive measures two weeks before leaving, and if you haven't had the vaccine yet, try the PCR test, among other preventive measures.

Tax Declarations

税金の申告



By submitting your tax return, you may be eligible for a reimbursement of some of the money you paid in tax. [Time] February 16 - March 15, 9am - 5pm *Reception will close at 4pm *Closed on weekends and public holiday [Venue] Yume Dome Ueno, 2nd Gymnasium *A tickets available in advance via the LINE app is required. You can pick it up at the venue on the day, but may be asked to come back at a later date. *When you come to the venue, please wear a mask, sanitize your hands and check your temperature at the gate. Anyone over 37.5° will not be allowed to enter. Thank you for your cooperation.

♦Who needs to submit a tax declaration?

- 1) Anyone that receives a salary but did not complete their year-end tax adjustment
- 2) Anyone who has received a salary from more than one company/employer during the year
- 3) Anyone who left their place of work and started a new job in the same year
- 4) Anyone who did not include information about their dependents in their year-end tax adjustment, etc.

- ♦ What do you need to make a tax declaration?
- 1) My number card, or My number notification card and Identification such as driver's license, health insurance card, passport, residence card, etc.
- 2) Declaration form (if you received from the tax office or City Hall)
- 3) Postcards from the tax office (if you received one)
- 4) The original copy of your certificate of income and withholding tax
- 5) Certificate for deduction; Documentation to prove that you are sending money to dependents overseas. / National health insurance certificate / National pension certificate / Proof of life insurance fee exemption
- 6) A copy of the bank book (tsuchou) for the bank account you would like your tax reimbursement to be sent to (the page which shows your name and account number)

*Municipal certifications and documents are issued upon presentation of your tax return slip. If those who are required to pay income tax, municipal and prefectural tax do not file their tax returns, they cannot be issued the relevant documents (proof of income, proof of taxes paid) that are needed in order to apply for changes in residency status, child benefit, educational support, public housing etc. They may not be able to access other public services, either. Join the National Pension Plan when you turn 20

20歳(はたち) になったら 国民年金

The National Pension Plan is a system that supports all working-age people for their retirement and other needs.

In addition to **Old-age pension** that will support the old age, also there are two other pensions; **Disability pension**, which is received in case of disability due to illness or accident

The bereaved pension, which is received by the family members of the deceased pensioner who was supported by the pensioner.

When you turn 20 years old, the Japan Pension Service (Nihon Nenkin Kikou) will send you a notice of enrollment in the National Pension Plan, a payment slip and your pension book (Nenkin Techou), excluding those who are already enrolled in an employee pension plan (Kousei Nenkin).

Those who have difficulty paying the National Pension Insurance premiums and wish to use the following systems need to apply. Please contact the inquiry desk.

◆ The Special Payment System for Students:

If you are a student and your income is below a certain amount, you can defer your pension payment.

Under the exemption and deferment system

If the income of the person, spouse, or head of household in the previous year is below a certain amount, they will be exempted from paying part or all of the insurance premiums.

- 1) Reside or work in Mie.
- ②Be in need of housing.
- 3Are up to date in your tax payments.
- ④If you have been living in public housing, you do not have any outstanding bills or payments (rent, parking fee etc).
- ⑤Plan to live with family members (including boyfriend, girlfriend).
- 6 Have an income within the required bracket to live in public housing.
- 7 Have two guaruntors.

Tips for Everyday Life

Are you paying your taxes properly? きちんと納税できていますか?

[Taxes in Japan]

In Japan, there is Income Tax paid to the national government and Resident Tax paid to local governments. Foreigners and Japanese pay the same taxes.

[Income Tax]

Income tax is a tax on income from January to December of the year. If you are working, it is deducted from your salary every month. Those who are self-employed should file their own tax returns at the tax office. [Resident Tax]

The Resident Tax is a tax on the income of the previous year. It is paid to the municipality in which you live as of January 1 every year.

If you do not pay the tax on time, you will be charged an overdue tax. Furthermore, if you do not pay the tax, it will be deducted from your salary, and it will also be difficult to obtain a naturalization or permanent residence visa. Don't forget to pay your taxes!

Medical Expenses under National Health Insurance

A notice of National Health Insurance medical expenses "国民健康保険 医療費 のお知らせ" will be sent to those who have received medical treatment at the Iga City National Health Insurance. Please do not lose this notice, as it can be used as a statement of medical expense deductions. *It cannot be reissued.

If there are expenses that are not listed in this notice, you need to prepare a "Statement of Deductible Medical Expenses" based on the receipts issued by the medical institution and attach it to your tax return. Keep receipts for five years after the tax filing deadline.




In developing this plan, we will conduct a questionnaire survey. We would appreciate your cooperation.
