COVID-19 Updates 新型コロチに関するお知らせ

Omicron Strain-Compatible Vaccines オミクロン株対応ワクチン追加接種

Persons 12 years of age or older who have received two or more doses and five months have passed since the last dose may receive the Omicron strain-compatible vaccine. When you receive your ticket, make an appointment with your medical institution to receive the vaccination.



COVID-19 Vaccine for Infants (6 months to 4 years of age) 乳効児 (生後6ヵ月~4歳) のワクチン接種

Three doses of Pfizer's vaccine for infants, which has been proven effective and safe, will soon be available for infants at four pediatric locations in the city. Details will be posted on the city's website.

What is Year-End Tax Adjustment (Nenmatsu Chousei) 雑業調整について

When companies calculate the monthly salaries of their employees, they calculate the amount of income tax that should be levied based on salary, social insurance payments and the number of dependents. This income tax is then deducted when the salary is paid. This is called 'tax deduction at source' (*gensen choushuu*).

However, the amount of income tax deducted each month is only a temporary figure, and the actual amount of income tax that is due to be paid is calculated at the end of each year. This means that you may actually have to pay more in tax than based on your monthly salary, or it might be the case that based on your monthly salary calculations you have been paying too much, and so are due a tax refund. This process, called 'year-end tax adjustment', takes place at the end of every calendar year. Why do adjustments need to be made?

- Reason 1: Your 'tax deduction at source' (gensen choushuu hyou) certificate is calculated on the assumption that your monthly salary does not change throughout the year, but in reality your salary might have changed throughout the course of the year, especially if you have switched jobs. The tax deduction at source system is the deduction of income tax from your salary, and this is the system used to pay tax in Japan.
- Reason 2: Throughout the course of the year, there may have been changes in the number of dependents, in which cases the amount of income tax you need to pay will also change.
- Reason 3: Life insurance and earthquake insurance are deducted in the year-end tax adjustment. However, this deduction means that there is an upper limit on the amount that can be deducted from income.



A Certificate of Deduction for Social Insurance Premiums (National Pension Insurance Premiums) 社会保険料(国民学会保険料) 建除証明書の発行

When you declare the residence tax and income tax, the full amount of your national pension premiums is subject to social insurance premium deduction (the premium payments you made from January 1st to December 31st of that particular year). In order to receive this social insurance premium deduction, you must attach proof that you have paid. Those who have paid national pension premiums between January 1 to September 30 will receive a 'social insurance (pension insurance) deduction certificate' from the Japan Pension Fund in late October. When filing tax returns or making year-end adjustments, this certificate (or receipt) must be attached.

Also, this same certificate will be sent to those who paid national pension insurance for the first time this year between October 1 and December 31 in early February of next year.

It should be noted that if you paid national pension insurance fees for any family members, the same members can be added to your social insurance premium deduction. In order to do this, be sure to attach their deduction certificates, too. - -Hit him on the head, because he would not listen despite repeated verbal warnings.
- -Threw him out of the house, because he didn't keep his promise.
- -Didn't give him dinner because he didn't do his homework and kept playing.
- -Hit him because he hit and injured his friend.

What is necessary to develop a child's personality and talents should be explained in words, shown by example, and demonstrated in a way that does not constitute corporal punishment.

Tips for Everyday Life 生活のヒント

Door-to-door Collection of Oversize Garbage -Sodai Gomi- 紅犬ごみ声別収集

Sodai Gomi such as furniture, bedding, bicycles, fan heaters, appliances, etc., can be collected at your home. A 200 yen disposal ticket must be attached to each item. Up to 5 items can be collected per application.

*Four designated home appliances (air conditioner, TV, refrigerator/freezer and washer/dryer) cannot be collected according to the Home Appliance Recycling Law.

[How to Use]

- Call the Sodai Gomi Uketsuke (Bulky Waste Reception) Center to request collection. 1)
- Purchase bulky waste disposal tickets at supermarkets in the city. 2)
- Put the garbage disposal ticket on the bulky waste and place it out on the appointed day at the appointed place by 9:00 a.m. (Aoyama area by 8:30 a.m.) *Your presence is not required.
